



Student Referral Scheme Policy

The following sets out how the College manages the Student Referral Scheme.

This Student Referral Scheme provides a financial incentive to former and current students at UK Business College (UKBC) to refer their friends, relatives, family, and colleagues to study at UKBC.

1) Introduction

1.1 The purpose of this Scheme is to recognise and reward alumni and current students who share their experiences and benefits of undertaking study at UK Business College (UKBC) with people they know (i.e., family, friends or colleagues). By encouraging and supporting a prospective student to enrol at UKBC, the referrer will be able to receive a financial reward.

1.2 This policy sets forth the circumstances under which current students and graduates may be compensated financially for referring new students to UKBC who subsequently enrol in any of UKBC's programmes. The policy will outline the expectations of all parties involved in this scheme, the terms and conditions and the process.

2) Classification

2.1 Referrer' is the term used for an individual who refers a friend, colleague or family member ("Referred Student") to UKBC.

2.2 "Referral" is the term used for the act of referring a student to UKBC.

3) Referral Scheme Process

3.1 Referrers must inform their friend, colleague, or family members of UKBC and share the course details with them.

3.2 Referrers must ask the Referred Student to complete the College's application form which can be found at: <https://online.ukbc.ac>

3.3 Referred Students must state the Referrer's full name and Student ID number on the application form.

3.4 Referred Students will be contacted by the Admissions team to complete the Admissions processes.

3.5 Referrers will then be contacted by UKBC if they qualify for the award and have fulfilled the Terms and Conditions outlined in Section 4

4) Terms and Conditions

4.1 The current student, who is known as the "referrer," agrees to these terms and conditions by taking part in the Student Referral Scheme. The referrer agrees that all UKBC decisions are final and binding by taking part.

4.2 The scheme is open to current students, graduates, and prospective students of UKBC only. This scheme is not open to UKBC's employees or their immediate families.

4.3 The "referrer" must be a current or former student of UKBC with no outstanding course fees.

4.4 The Referral Scheme entitles you to £500 per referral payable either as a cash payment via bank transfer or an Amazon voucher. This amount is not negotiable.

4.5 UK Business College (UKBC) only permits a maximum of ten successful referrals per intake.

4.6 The "referrer" will only receive payment for each new student referred, provided that:

4.6.1 The "referrer" name and Student ID number be included in the "Referred Student" application form.

4.6.2 UKBC must have received the first payment of fees from the "Referred Student".

4.6.3 The "Referred Student" is fully registered in the program and has completed their first semester.

4.6.4 The "referrer" has successfully completed the claim form.

4.6.5 At the end of the first academic term/semester, the referred student must not be indebted to UKBC in any way whatsoever or subject to disciplinary procedure(s) including academic matters.

4.5.6 UKBC expects that all referrers conduct themselves in an honest and respectful manner towards UKBC staff. Any "referrer" found to not do this may be excluded from the scheme resulting in no payments being made.

5) The Process of Payment

5.1 The referrer is entitled to £500 per referral payable either as a cash payment via bank transfer or an Amazon voucher for each new student if all the conditions set out in section 4 are satisfied.

5.2 Your payment is subjected to HMRC PAYE income tax and national insurance deductions. It is the responsibility of the "referrer" to declare such earnings to the HMRC.

5.3 Payments will be made approximately five months after referral. Timescales vary

depending on the course being studied.

5.4 The UKBC Referral Team will communicate with all eligible referrers only. All referrers will be expected to complete a claim form.

5.5 Once the referrer has provided the completed claim form, the UKBC Referral Team will acknowledge the completed claim form. From the date of the acknowledgment response, the payment will be made within **30 working days**.

5.6 UKBC will make an effort to complete the payment within the agreed-upon deadline, this might not always be achievable depending on the number of claims. If their payment is not made by the deadline, referrers are recommended to email the finance department at finance@ukbusinesscollege.org and request a full update.

5.7 Payments will only be made by bank transfer only (BACS). No other form of payment will be processed.

5.8 The "referrer" is accountable for giving UKBC the right payment information. If incorrect payment information is given, UKBC will not be held liable. The processing time may lengthen in such circumstances.

6) Referral Scheme Changes

6.1 UKBC reserves the right to alter the terms and conditions of the scheme at any point.

7) Governing Law

7.1 Any disagreement or claim arising out of or relating to these terms, their content, or their formation (including non-contractual disagreements or claims) shall be governed by and interpreted in accordance with England and Wales.

8) Data Protection Guidelines

8.1 In order to perform its obligations, UKBC must collect, store, and manage personal information about its current and potential students.

8.2 UKBC is dedicated to fully adhering to all applicable data protection legislation, including the UK's *General Data Protection Regulation* and the *Data Protection Act of 2018*. For the majority of the personal data it handles, UKBC acts as a controller (UK GDPR).
